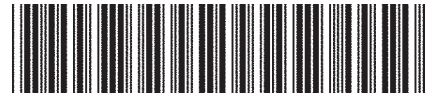

BE IT RESOLVED THAT:

- 1. The Heritage Educational Foundation (the "Heritage Foundation"), and/or its agent, Knowledge First Financial Inc., the manager of the Heritage Plans ("Knowledge First") be authorized to amend, as necessary in its sole discretion, the Heritage Plans Education Savings Plan Contract for the Heritage Self-Determined Plan (the "ESP Contract"),
 - a. to grant the Heritage Foundation and/or Knowledge First, the discretion to transfer (the "Transfer") the assets from the Heritage Self-Determined Plan to the Family Single Student Education Savings Plan sponsored by the Knowledge First Foundation, an affiliate of the Heritage Foundation (the "Single Student Plan"), and
 - b. to allow the Heritage Foundation and/or Knowledge First, to enter into an Educational Assistance Agreement for the Single Student Plan on behalf of each Heritage Self-Determined Plan Customer with Knowledge First Foundation and/or Knowledge First,
 in the manner described in the Management Information Circular of the Heritage Plans dated March 24, 2021, and to terminate the ESP Contract with each Customer as required in the sole discretion of the Heritage Foundation and/or Knowledge First;
- 2. The Heritage Foundation and/or Knowledge First, be authorized to amend the Amended and Restated Trust Indenture between the Heritage Foundation and The Bank of Nova Scotia Trust Company dated as of November 1, 2018 (the "Trust Agreement"), as it deems necessary, in its sole discretion, to permit the Transfer;
- 3. The Heritage Foundation and/or Knowledge First, be authorized to terminate the Trust Agreement if necessary, in its sole discretion;
- 4. The Heritage Foundation and/or Knowledge First, be authorized, in its sole discretion, to elect not to proceed with any or all of the Transfer, the amendment or termination of the ESP Contract or the amendment or the termination of the Trust Agreement; and
- 5. Any director or officer of the Heritage Foundation and/or Knowledge First, be and is hereby authorized, in their sole discretion, to take all such steps as may be necessary or desirable to give effect to the foregoing.
